

*Description of Existing footpaths*

A-B. That part of Public Footpath No. 7 Parish of South Normanton commencing at point A (GR 438 554) and proceeding in a south-easterly direction to point B (GR 438 553) a distance of 99 metres or thereabouts.

B-C. That length of public footpath in the parish of South Normanton created by the Stopping-Up of Highways (County of Derby) (No. 2) Order 1967 commencing at the aforesaid point B and proceeding in an easterly direction to point C (GR 439 553) a distance of 75 metres or thereabouts.

C-D. That part of Public Footpath No. 6 Parish of South Normanton from the aforesaid point C and proceeding in an east-north-easterly direction to point D (GR 439 553) on Birchwood Lane, South Normanton, a distance of 26 metres or thereabouts.

E-F. That length of public footpath in the parish of Pinxton created by the Stopping-Up of Highways (County of Derby) (No. 2) Order 1967 from Point e (GR 439 553) on Birchwood Lane and proceeding in a westerly direction to point F (GR 438 553) a distance of 60 metres or thereabouts.

F-G. That part of public footpath No. 6 parish of South Normanton from the aforesaid point F proceeding in a south-westerly direction to point G (GR 436 551) a distance of 356 metres or thereabouts.

*Description of Alternative footpath*

A-H. Commencing at the aforesaid point A and proceeding in a generally easterly direction between the fence line and earth bank to point D (GR 439 554) a distance of 151 metres or thereabouts.

If no representations or objections are duly made, or if any so made are withdrawn, the Derbyshire County Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

## NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

*The Derbyshire County Council (Public Footpath between Petersgate and Bracken Close, Long Eaton) Public Path Diversion Order 1980.*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 7th August 1980 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Derbyshire County Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert the public right of way (more particularly described below) to allow the construction of a hostel for the mentally handicapped and create an alternative line of footpath (more particularly described below).

A—C—B	Commencing at the aforesaid Point A and proceeding in a generally south-easterly direction to Point C (GR 4747 3437) and thence in an easterly direction to the aforesaid Point B for a distance of 110 metres or thereabouts.

*The Exeter City Council (Part of Princesshay) Public Path Stopping Up Order, No. 2, 1979*

Notice is hereby given that on 29th July 1980, the Secretary of State confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish the public right of way over a part of Princesshay, Exeter, with a maximum length of 24 feet 10 inches or thereabouts and with a maximum width of 15 feet or thereabouts situated between on the one side Eastgate House, Exeter, beside the shop premises therein presently known as "Country Casuals" and on the other side Princess House, Exeter, beside the shop premises therein presently known as "Waring and Gillow", and shown edged in black on the plan annexed to the Order.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at Room 3.7 the City Secretary and Solicitor's Office, Civic Centre, Exeter, between 9 a.m. and 4 p.m. on Mondays to Fridays.

The Order becomes operative from 15th August 1980, but if a person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971 or on the ground that any requirement of that Act or any Regulation made hereunder has not been complied with in relation to the confirmation of the Order, he may under section 244 of the Town and Country Planning Act 1971 within 6 weeks from 15th August 1980 make application for the purpose to the High Court.
