

## Y SWYDDFA GYMREIG

## TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 212 of the Town and Country Planning Act 1971 for extinguishing any rights which persons may have to use vehicles on those lengths of highway specified in the Schedule to this Notice.

The proposed Order will contain provisions for permitting the use of the highway by vehicles being used:

- (a) for Police, Ambulance or Fire Brigade purposes;
- (b) on behalf of a statutory undertaker, a water authority or the Post Office and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal or any sewer, sewage disposal work, land drainage work, watercourse or of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any telegraphic line as defined in the Telegraph Act 1878 under, in, on, over, along or across the highway or any land adjacent to the highway;
- (c) in accordance with a special authorisation for that use given by or on behalf of the Gwent County Council, the Newport Borough Council or the Chief Officer of Police for that area.

Copies of the Order and relevant plan may be inspected at all reasonable hours at the offices of the Newport Borough Council, Civic Centre, Newport, and may be obtained, free of charge, on application to the Secretary of State, Welsh Office (Y Swyddfa Gymreig) Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, quoting Ref. WR15/34/15.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 4th September 1980, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to a highway to which the Order relates shall be entitled to be compensated by the Newport Borough Council as the local planning authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.

## SCHEDULE

*Lengths of highway at Newport in the County of Gwent*

- (a) That length of Courtybella Street which extends from its junction with Commercial Road in a north-westerly direction for a distance of 67 yards.
- (b) That length of Courtybella Street which extends from its junction with Temple Street in a south-easterly direction for a distance of 52 yards.
- (c) That length of Courtybella Street which extends from its junction with Temple Street in a south-easterly direction for a distance of 43 yards. (2 SI)
