The Trunk Road (Porthmadog, Gwynedd) (Prohibition of Waiting) Order 1980

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974. The effect of the Order will be to prohibit the waiting of any vehicle at any time on the side of road specified in the Schedule to this Notice. Exceptions in the Order will permit waiting for the following numbers:

following purposes:
