NOTICE OF PUBLIC FOOTPATH ORDER

HIGHWAY ACT 1959—SECTION 111

The South Staffordshire District Council Public Path (Huntington No. 2) Diversion Order 1980

Notice is hereby given that the above-named Order, made on 4th September 1980, is about to be submitted to the Secretary of State for the Department of the Environment for confirmation, or to be confirmed, as an unopposed Order, by the South Staffordshire District Council.

The effect of the Order, if confirmed without modification, will be to divert that part of the above right-of-way commencing at a point 'A' immediately adjoining No. 25 Stafford Road, Huntington and running in a generally north-westerly direction for a distance of approximately 36 metres to a point 'B' at the rear of the said property, to a line starting from a point 'C' approximately 34 metres north-east of the aforementioned point 'A' and running in a generally westerly direction for a distance of approximately 25 metres to a point 'D' at the rear of number one Wrekin View, Huntington and then in a generally south-westerly direction for a distance of approximately 12 metres to rejoin the path at the aforementioned point 'B'.

A copy of the Order and map contained in it has been deposited and may be inspected free of charge at the Council Offices, Codsall during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the undersigned before 10th October, 1980 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the South Staffordshire District Council may instead of submitting the Order to the Secretary of State for the Department of the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State, any representations and objections which have been duly made and not withdrawn shall be transmitted with the Order.

Sevenoaks District Council F.P. 614 (Part) Edenbridge Public Path Diversion Order No. 2 1979

Notice is hereby given that on 12th September 1980 the Sevenoaks District Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert that part of the public path numbered 614 in the Parish of Edenbridge leading from a point 160 metres or thereabouts from the path's commencement point on the south side of Lingfield Road, Edenbridge, thence in a generally south-south-westerly direction to the south-west corner of Ordnance Survey parcel No. 0075, a distance of 200 metres or thereabouts, thence in a generally south-westerly direction to the south-west corner of O.S. Parcel No. 0058, a distance of 220 metres or thereabouts, thence in a southerly direction, inside the western boundary of O.S. No. 0045 for a distance of 90 metres or thereabouts, thence in a generally south-south-westerly direction to the south-west corner of O.S. parcel No. 7229, a distance of 420 metres or thereabouts, thence in a westerly direction in O.S. parcel No. 5330 for a distance of 20 metres or thereabouts to a new line (a) from a point 160 metres or thereabouts from the path's commencement point on the south side of Lingfield Road, leading in an easterly direction inside the northern boundary of O.S. 0075 for a distance of 90 metres or thereabouts, thence in a generally south-south-westerly direction, inside the north-easterly boundary of O.S. parcel No. 0075 for a distance of 55 metres or thereabouts, thence in a generally south-south-westerly direction inside the eastern boundaries of O.S. parcel No. 0075 and O.S. parcel No. 0058 to a point in the south-east corner of O.S. parcel No. 0058, where the path crosses the footbridge over Kent Brook, a distance of 330 metres or thereabouts, thence in a generally southerly direction along the western side of a drain running approximately parallel to the eastern

boundary of O.S. parcel No. 0045 for a distance of 120 metres or thereabouts, thence in a generally south-westerly direction along the south-east boundary of O.S. parcel No. 0031 (along the north bank of the River Eden) for a distance of 425 metres or thereabouts, to a point at the south-west corner of O.S. parcel No. 0031 (south of Devils Den), thence in a generally westerly direction inside the southern boundary of O.S. parcel No. 7229 for a distance of 215 metres or thereabouts to a point at the south-west corner of O.S. parcel No. 7229 thence in a westerly direction for 20 metres or thereabouts along the southern boundary of O.S. parcel No. 5330 to where it joins the existing route, and (b) from the footbridge over Kent Brook in the south-east corner of O.S. parcel No. 0058 in a generally westerly direction along the southern bank of Kent Brook (the northern boundary of O.S. parcel No. 0045) to join the existing path at its junction with Footpath 616 in the north-western corner of parcel No. 0045.

And further, divert that part of public path numbered 614, in the Parish of Edenbridge which leads in a south-westerly direction from a point on the north-east corner of O.S. parcel No. 3400 to a point on the north bank of the River Eden where the path crosses over a footbridge, a distance of 330 metres or thereabouts to a new line leading from a point on the north-east corner of O.S. parcel No. 3400 where the proposed diversion leaves the existing path and leading in a south-westerly direction inside the eastern boundary of O.S. parcel No. 3400 for a distance of 80 metres or thereabouts, to a point at the south-east corner of O.S. parcel No. 3400, thence in a generally westerly direction along the north bank of the River Eden for a distance of 450 metres or thereabouts to a point where a footbridge crosses the River Eden on the western boundary of O.S. parcel No. 3400. The width of the new path is to be 1.8 metres.

A copy of the confirmed Order and the map contained in it has been deposited and may be inspected free of charge at the Council Offices, Argyle Road, Sevenoaks between 9 a.m. and 4.30 p.m. on weekdays, Mondays to Fridays and the Edenbridge Public Library, Church Street, Edenbridge, Kent during the hours when the library is open. The Order became operative on 12th September 1980 but if a person aggrieved by the Order desires to question the validity thereof, or any provision contained thereon on the grounds that it is not within the powers of the Highways Act 1959, as amended, or on the grounds that any requirement of the Act, as amended, or if any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 1 of the Act as applied by paragraph 5 of Schedule 7 of the Act, within 6 weeks from the date of publication of this notice, make an application for that purpose to the High Court.

The Surrey County Council Public Footpath (Right of Way No. 366A Felbridge) Diversion Order 1979

Notice is hereby given that on Wednesday, 10th September 1980, the Surrey County Council confirmed the above-named order.

The effect of the Order, as confirmed, will be to:

To divert part of public footpath No. 366A in the parish of Felbridge by stopping-up that section of the footpath from a point at its junction with Herons Lea for a distance of approximately 68 metres in an easterly direction and substituting a new length of public footpath from a point at its original junction with Herons Lea for a distance of approximately 40 metres in a southerly direction to the junction between Herons Lea and Herons Close and thence in an easterly direction along Herons Close for a distance of approximately 60 metres to the eastern boundary of his property known as "Poppins" and thence in a northerly direction for a distance of approximately 40 metres.
