NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby $g_{1,e}$ you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely:

One V-Benardelli Cardone VT pistol of 7.65 mm. calibre number 64907 imported by you at Leith Docks on 30th July 1979 and there detained by an officer of customs,

have been seized as liable to forfeiture upon the ground that they were imported into the United Kingdom con-trary to the prohibition imposed by Article 1 of the Import of Goods (Control) Order 1954 (SI 1954 No. 23) made under the Import, Export and Customs Powers (Defence) Act 1939, section 1. Whereby and by force of section 3 (1) of the aforementioned Import, Export and Customs Powers (Defence) Act 1939 and section 49 (1) (b) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture. are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accord-ance with the said Schedule to the said Act specifying the name and address of a solicitor in Scotland who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Com-missioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal pro-ceeding will be taken for the used durantic time. ceedings will be taken for the condemnation thereof.
