NEW TOWNS ACT 1965

The New Town of Skelmersdale Extinguishment of Public Rights of Way Over Footpath No. 105, Fosters Green

Notice is hereby given that the Secretary of State for the Environment, in exercise of his powers under section 23 of the New Towns Act 1965, has made an Order extinguishing as from the date of the Order the public rights of way over the following highway, shown coloured red on the map referred to therein:

That part of footpath No. 105 at Fosters Green from a point marked A on the map at its junction with Elmers Green Lane on the western boundary of Sherwood Farm and running in an easterly direction for approximately 94 metres to a point marked B on the map at its junction with the boundary fence on Stannanought Road.

A copy of the Order which is dated 9th September 1980 and of the map referred to in it showing the rights of way which have been extinguished and the alternative routes already provided and coloured yellow may be inspected at the offices of the Skelmersdale Development Corporation, Pennylands, Skelmersdale, during normal office hours.
