#### PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on 13th October 1980 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices and parishes of St. James, Wednesbury and St. John, Wednesbury, in the diocese of Lichfield, and declaring redundant the parish church of the parish of St. John, Wednesbury.

2.—(1) Uniting the benefices of Redruth and Christ Church, Lannarth and establishing a team ministry for the new benefice;

(2) uniting the benefices of Saint Stithians with Perranarworthal; and Gwennap, and

(3) altering the areas of the parishes of Gwennap; Christ Church, Lannarth; and St. Day, in the diocese of Truro.

3. Declaring redundant the church of The Good Shepherd, Iping Marsh, a chapel of ease in the parish of Lynch with Iping Marsh, in the diocese of Chichester.

4.—(1) Uniting the parishes of Stoke Lacy and Moreton Jeffries;

(2) altering the name of the benefices of Stoke Lacy with Much Cowarne, Moreton Jeffries, Ocle Pychard and Ullingswick;

(3) declaring redundant the parish church of the parish of Moreton Jeffries, in the diocese of Hereford.

5. Uniting the benefices of Smallburgh with Dilham; and Honing with Crostwight, in the diocese of Norwich.

6. Enlarging the Trowbridge Group Ministry, in the diocese of Salisbury, to include the benefices of Hilperton with Whaddon; and Staverton.

7. Uniting the benefices of Spaxton with Charlynch; and Enmore with Goathurst, in the diocese of Bath and Wells.

8.—(1) Uniting the benefices and parishes of St. Margaret, Leicester; and St. Leonard, Leicester;

(2) declaring redundant the parish church of the parish of St. Leonard, Leicester, and

(3) altering the areas of the parishes of St. Margaret, Leicester; and Belgrave, in the diocese of Leicester.

9. Uniting the parishes of Asthall; Swinbrook; and Widford; and uniting the benefices of Asthall and Swinbrook with Widford; and Burford with Fulbrook and Taynton, in the diocese of Oxford.

10. Declaring redundant the parish church of the parish of Pitchcott, in the diocese of Oxford.

11. Creating a new benefice and parish of Christ the Cornerstone, Milton Keynes, out of parts of the parishes of Loughton, Stantonbury and Woughton, in the diocese of Oxford.

12. Uniting the benefices of Aylton with Pixley, Munsley and Putley; and Tarrington with Stoke Edith, in the diocese of Hereford.

13. Uniting the benefices of Ranworth with Panxworth; and Woodbastwick, in the diocese of Norwich.

14. Uniting the benefices of St. Mary, Freeland; and Cassington, in the diocese of Oxford.

15. Uniting the parishes of Kingerby; and Kirkby cum Osgodby and declaring redundant the parish church of the parish of Kingerby, in the diocese of Lincoln.

16. Declaring redundant the church of Boveridge, St. Aldhelm, in the parish of Cranborne with Boveridge, in the diocese of Salisbury.

17. Altering the areas of the parishes of Madeley, in the diocese of Hereford, and Central Telford, in the diocese of Lichfield.

18. Uniting the benefices of Burton Pedwardine; and Heckington with Howell, in the diocese of Lincoln.

19. Uniting the benefices of St. Martin-in-the-Cornmarket and St. Paul, Worcester, in the diocese of Worcester.

20. Creating a new benefice and parish of St. Mary Magdalene, Gorleston, in the diocese of Norwich.

21. Rearranging the benefices of Brize Norton and Carterton; and Minster Lovell, in the diocese of Oxford.

22. Declaring redundant the parish church of the parish of St. Aidan Benwell, in the diocese of Newcastle.

23. Uniting the benefices of Milverton; Halse; and Fitzhead, in the diocese of Bath and Wells.

24. Appropriating part of the churchyard of the parish church of the parish of Clanfield, in the diocese of Ports-
