The Trunk Road (Milford Haven, Dyfed) (40 m.p.h. Speed Limit) Order 1980

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 74 (1) and 84D (1) of the Road Traffic Regulation Act 1967, as amended which shall come into operation on 6th November 1980. The effect of the Order is:

(a) that no person shall cause or permit any motor vehicle to proceed at a speed exceeding 40 miles per hour in the length of road specified in the Schedule to

(b) to revoke the existing 40 m.p.h. Speed Limit Order, i.e. The Trunk Roads (40 m.p.h. Speed Limit) (No. 76) Order 1963.
