#### PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on 11th November 1980 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Brockdish with Thorpe Abbots; and Scole with Billingford and Little Thorpe, in the diocese of Norwich.
2. Appropriating part of a detached burial ground as an addition to the grounds of the new parsonage house of the benefice of Great Faringdon with Little Coxwell, in the diocese of Oxford.
3. Uniting the benefices of Blagdon; and Compton Martin with Ubley, in the diocese of Bath and Wells.
4. Uniting the benefices of Norton Bishop's (otherwise known as Bishop Norton); and Wadingham with Snitterby, and for altering the names of the parishes of Norton Bishop's and Wadingham, in the diocese of Lincoln.
5. Uniting the parishes of Malpas and Threapwood, in the diocese of Chester.
6. Establishing a group ministry for the benefices of Kidderminster; St. George, Kidderminster; St. John the Baptist, Kidderminster; Holy Innocents, Foley Park; and St. Oswald-in-Usmere, Broadwater, in the diocese of Worcester.
7. Transferring part of the parish of Monkton Wyld, in the diocese of Salisbury, to the parish of Uplyme, in the diocese of Exeter.
8. Uniting the parishes of St. George, Barrow-in-Furness and St. Luke, Barrow-in-Furness, in the diocese of Carlisle; and establishing a team ministry for the area of the benefice of St. George with St. Luke, Barrow-in-Furness.
9. Uniting the benefices of Tring; Aldbury; and Puttenham with Long Marston; uniting the parishes of Tring; Aldbury; Puttenham; and Long Marston, in the diocese of St. Albans; and establishing a team ministry for the area of the new benefice.
10. Uniting the benefices of Blackmore; and Stondon Massey, in the diocese of Chelmsford.
11. Uniting the benefices of Hendon and Sunderland, in the diocese of Durham.
12. Uniting the parishes of Leighton under the Wrekin; Eaton Constantine; and Wroxeter; uniting the benefices of Buildwas; Leighton and Eaton Constantine; and Wroxeter; and declaring redundant the parish church of the parish of Wroxeter, in the diocese of Lichfield.
13. Uniting the benefices of Barton Stacey with Bullington; and Longparish with Hurstbourne Priors, in the diocese of Winchester.
14. Uniting the benefices and parishes of Upper Stour, in the diocese of Salisbury, and Kilmington, in the diocese of Bath and Wells.
15. Revoking an earlier Scheme and creating the new benefices of Abbotsbury, Portesham and Langton Herring; and Bincombe with Broadway, Upwey and Buckland Ripers, in the diocese of Salisbury.
16. Uniting the benefices of Grindon and Stillington, in the diocese of Durham.
17. Uniting the benefices of Chilcompton; Downside; and Stratton on the Fosse; and uniting the parishes of Chilcompton and Downside, in the diocese of Bath and Wells.
18. Uniting the benefices of Aysgarth and Bolton cum Redmire, in the diocese of Ripon.
19. Uniting the benefices of Hermitage with Hampstead Norreys; St. Mark, Cold Ash; and Yattendon with Frilsham; and establishing a team ministry for the area of the new benefice, in the diocese of Oxford.
20. Declaring redundant the church of St. James, West Tilbury, in the diocese of Chelmsford.
21. Uniting the benefices of Filby with Thrigby with Mautby; Runham; and Stokesby with Herringby, in the diocese of Norwich.
22. Uniting the benefices and parishes of St. Michael and All Angels, Croydon, and St. James, Croydon Common, in the diocese of Canterbury; and declaring redundant the parish church of the parish of St. James, Croydon Common.
23. Re-arranging the benefices and parishes of Brighton, St. Peter with the Chapel Royal and St. John the Evangelist, Brighton; and the parishes of St. Mary, Kemp Town; The Annunciation, Brighton; and The Resurrection,
