#### NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT 1949

*Declaration of Nature Reserve Communities of Caron-is-Clawdd, Caron-uwch-Clawdd, Gwnnws Isaf and Lledrod Uchaf.*

Notice is hereby given in pursuance of section 19 of the above-mentioned Act that by the Cors Caron Nature Reserve No. 1 Declaration 1981, made on 22nd January 1981, the Nature Conservancy Council declared that the land containing 745.02 hectares (1863.25 acres) or thereabouts situate in the Communities of Caron-is-clawdd, Caron-uwch-clawdd, Gwnnws Isaf and Lledrod Uchaf, in the County of Dyfed, and shown edged red on the plan attached to the said Declaration has been acquired and is being held by the Council and that the said land is being managed as a Nature Reserve.

Notice is also hereby given in pursuance of section 19(3) of the above-mentioned Act that the Nature Conservancy Council further declared that the land containing 729.92 hectares (1803.7 acres) or thereabouts situate in the Communities of Caron-is-clawdd, Caron-uwch-clawdd and Lledrod Uchaf and shown edged blue on the plan attached to the said Declaration has ceased to be the subject of Agreements entered into with the Council under the provisions of section 16 of the above-mentioned Act and that the four areas edged blue in the Community of Lledrod Uchaf containing 11.6 hectares (28.7 acres) or thereabouts lying outside the red boundary have ceased to be managed as a Nature Reserve.

Notice is also hereby given that in pursuance of section 19(4) of the above-mentioned Act that the Nature Conservancy Council hereby further declared that firstly the land containing 15.44 hectares (38.16 acres) or thereabouts and shown hatched green on the plan attached to the said Declaration, which was included in the Tregaron Bog Nature Reserve No. 1 Declaration 1955, and secondly the land containing 22.50 hectares (55.603 acres) or thereabouts and shown edged green on the plan attached to the said Declaration, comprised in the Cors Tregaron Nature Reserve No. 3 Declaration 1964, will hereafter be deemed to be included in the Cors Caron Nature Reserve.

Certified copies of the said Declaration with plan attached have been deposited for public inspection free of charge at the office of the Ceredigion District Council in Aberystwyth and the office of the Dyfed County Council in Carmarthen from Monday to Friday inclusive during normal office hours.

Certified copies may also be inspected at the offices of the Nature Conservancy Council at 19/20 Belgrave Square, London SW1X 8PY, and at Plas Gogerddan, Aberystwyth, Dyfed SY23 3EB, from Monday to Friday inclusive during the normal office hours.

#### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

##### HIGHWAYS ACT 1959

##### COUNTRYSIDE ACT 1968

*Aylesbury Vale District Council (Parish of Radclive-Cum-Chackmore Footpath No. 4) Public Path Extinguishment Order 1978.*

Notice is hereby given that on 24th October 1980 the Secretary of State for the Environment confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish the public right of way specified in the Schedule to this Notice.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Aylesbury Vale District Council Offices, The Mall, Friars Square, Aylesbury, and at the Area Office, Bank House, Bridge Street, Buckingham, during normal office hours.

The Order becomes operative 28 days from 23rd January 1981, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended or any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act, as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 23rd January 1981, make an application for the purpose to the High Court.

##### SCHEDULE

##### *Description of Length of Path or Way to be Extinguished*

Commencing from its entrance off the Chackmore/Tingewick Road, adjacent to the property known as 1 New College Cottages, Radclive; then continuing north-north-easterly for a distance of approximately 10 metres; then, lastly bearing generally northerly for a distance of approximately 140 metres to where it connects with the existing footpath also known as footpath No. 4 approximately 20 metres south of the former railway crossing. The path to be extinguished has a width throughout of approximately 1 metre.

##### HIGHWAYS ACTS 1959 AND 1980

*The Cheshire County Council (Parish of Barrow No. 15, Chester) Public Path Diversion Order 1978*

Notice is hereby given that on 16th January 1981 the Cheshire County Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert part of the footpath No. 15 Barrow, Chester, running from a point just north of the junction of Barrowmore Farm Road (UC2/89) and Hollowmore Heath Road (C831) at grid ref. 4780 6880 for a distance of approximately 250 metres to a point 4805 6882 to a line running from a point at the junction of the said Hollowmore Heath Road and Barrowmore Farm Road for a distance of approximately 225 metres to join the existing footpath 15 of the said point 4805 6882.
