HARBOURS ACT 1964

The Conwy Harbour Revision Order

Notice is hereby given that a Public Local Inquiry in connection with the above Order will be held by Mr. T. G. Holden, L.L.B. (a person appointed by the Secretary of State for Wales for the purpose) at 10.30 a.m. on Tuesday, 17th March 1981 in the Civic Hall, Conwy to hear objections made to the above Order and at his discretion to hear representations from any persons who may desire to appear and be heard.

A copy of the Order and of the map referred to therein may be seen at all reasonable hours at the offices of Aberconwy Borough Council, Council Offices, Builder Street, Llandudno, Gwynedd.

The said Order is an Order which has been applied for by the Aberconwy Borough Council under the above Act and which if confirmed by the Secretary of State and subject to Special Parliamentary Procedure under the Statutory Orders (Special Procedure) Act 1945 will authorise the Council:

1. To alter the limits within which the Council have jurisdiction as harbour authority for Conwy harbour so as to comprise the area set out in the Schedule to this notice and to include therein the works and conveniences, lands, buildings and property vested in, occupied or administered by the Council for the purposes of Conwy harbour (hereinafter referred to as "the harbour");
2. To empower the Council to improve, maintain and manage the harbour and its facilities including power to deepen, dredge, scour, cleanse, alter and improve the bed and foreshore of the harbour and purchase, etc., and use dredgers, tugs or other craft;
3. To empower the Council to provide boating or marina facilities and to provide and place, lay down, maintain, use and have moorings for vessels and houseboats, to make charges for the use of moorings, to require the removal of moorings, to grant licences to persons to place, lay down, maintain, use and have moorings and to change for the granting of such licences;
4. To empower the Council to remove goods left in the harbour if not removed on request by the owner;
5. To empower the Council to give directions as to the place of loading or unloading goods of specified description;
6. To require the owner or master of vessels carrying dangerous goods to notify the harbour master;
7. To empower the Council to provide parking facilities;
8. To empower the Council to remove unauthorised vessels and vehicles;
9. To empower the Council to give directions to secure conditions conducive to the ease, convenience or safety of navigation and safety of persons and property in the harbour. These may include:
 - (a) designating areas routes or channels in the harbour which vessels are to use or refrain from using for movement or mooring;
 - (b) securing that vessels move only at certain times or during certain periods;
 - (c) requiring the master of a vessel to give the harbour master information relating to the vessel reasonably required by him for effecting the above.
 A general direction may apply to all vessels, or to a class of vessels, to the whole or part of the harbour and at all or at designated times.
10. To make provision with regard to the manner in which notice of a general direction and of any amendment or revocation thereof shall except in case of emergency be given;
11. To provide the manner in which a special direction may be enforced;
12. To provide that the giving of a general direction or a special direction shall not diminish or in any other way affect the responsibility of the master of the vessel to which the direction is given in relation to the vessel, persons on board, its cargo, or to any other person or property;

13. To confer on the Council power to make byelaws in relation to the harbour for purposes specified in the order;
 14. To empower the Council to charge for services and facilities provided and to determine the manner of making demands, and recovering charges;
 15. To revoke the Conwy Harbour Order 1878 and to apply certain provisions of the Harbours, Docks and Piers Clauses Act 1847.

SCHEDULE

Limits of the Harbour

1. In this Schedule:

- "the Conway" means the river Conway;
- "the landward limit" means an imaginary straight line drawn across the Conway commencing on the line of the level of high water at a point having a National Grid reference of SH 7940 7590 and terminating on the line of the level of high-water at a point having a National Grid reference of SH 8018 7605;
- "the level of high water" means the level of mean highwater springs;
- "the seaward limit" means an imaginary straight line drawn across the estuary of the Conway commencing on the line of the level of high water at a point having a National Grid reference of SH 7489 7854 and terminating on the line of the level of high water at a point having a National Grid reference of SH 7748 8010.
2. The limits shall commence at the landward limit and shall comprise so much of the Conway and the sea (including all islands, streams, creeks, waters, water-courses and channels therein) as for the time being lie within the landward limit and the seaward limit, the seashore and the banks of the Conway and waters as is at or below the level of high-water.
