THE IMPORTED FOOD REGULATIONS 1968,
AS AMENDED

Denmark: Official Certificate

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly give notice that in exercise of the powers conferred on them by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973 and 1979 (S.I. 1973 No. 1351 and S.I. 1979 No. 1426), and the Transfer of Functions (Wales) (No. 1) Order 1978 (S.I. 1978 No. 272) they hereby restrict recognition of the Official Certificates reproduced in Part I of the First Schedule to the Notice published in the *London Gazette* dated 23rd January 1969 and in the Schedules to the notices published in the *London Gazette* dated 21st August 1973 and 13th July 1979 for the importation of meat and meat products from Denmark, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 4th November 1980 is hereby revoked.

NOTICE OF APPLICATION FOR LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Thames Water Authority by M. ROAD TRAFFIC ACTS

AVON COUNTY COUNCIL

County of Avon (Various Roads, Downend and Oldland, District of Kingswood) (One-Way Traffic) Order 1981

Notice is hereby given that on 29th January 1981 the County Council of Avon made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended, the effect of which is to introduce one-way

traffic working on the lengths of road specified in column 1 of the Schedule to this Notice in the direction specified in relation to that length of road in column 2 of the said Schedule.

The Order will come into operation on 12th February 1981 and a copy thereof together with a map may be inspected at the undermentioned offices (Sixth Floor) during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.
