- 11392/80 (COM (80) 724). Proposal for a Council Regulation on the common organisation of the market in fishery products.
- 4077/81 (COM (80) 809). Proposal for a Council Decision setting up an information and consultation procedure for relations and agreements with third countries in the field of transport by rail, road and inland waterway.
- 4142/81 (COM (80) 897). Proposal for a Council Regulation (EEC) amending Regulation (EEC) No. 926/79 on common rules for imports because of the accession of Greece.
