Extinguishment of Public Rights of Way. The New Town of Basildon. Parts of Rectory Road, Felmore 3D and 3E Housing Areas

DEPARTMENT OF TRANSPORT

The Trunk Road (Stoney Cross, Cadnam) (Prohibition of use of gaps in Central Reservation) Order 1981

The Secretary of State for Transport proposes to make an Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 on the Folkestone-Honiton Trunk Road (A31) in the District of New Forest in the county of Hampshire.

The effect of the Order would be to close the following gaps in the central reservation of the trunk road:

- (a) at Stoney Cross junction with C17.
- (b) Opposite the Compton Arms Hotel.
- (c) At Malwood Hill.

- (d) Opposite the Running Hill turning (Malwood Farm).

The existing gap west of the turning to Minstead will be retained to serve traffic from Minstead, the Southern Electricity Board area offices at Malwood and the public bus service. However, the effect of the Order would be to prohibit "U" turns and right hand turns through this gap from the eastbound carriageway.

The Trunk Road (A483 Gobowen) (Prohibition of Waiting) Order 1981

The Secretary of State for Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and by Schedule 6 of the Road Traffic Act 1974, on the Swansea-Manchester Trunk Road (A483) at Gobowen in the borough of Oswestry, in the county of Shropshire.

The effect of the Order will be to prohibit waiting at any time on either side of the Trunk Road, from a point 44 metres south of its junction with Trewern Avenue to a point 82 metres north of that junction.

Exemptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building, industrial or demolition operations, the removal of any obstruction to traffic or the maintenance of the road or services therein. Disabled persons will be exempt from the waiting restrictions for periods of up to 2 hours with no return within one hour.

AVON COUNTY COUNCIL

*Avon County Council (Lodge Causeway and Fishponds Road
Area, Bristol) (Prohibition and Restriction of Waiting)

5. To introduce limited waiting between the hours of 8 a.m. and 4.30 p.m. on Monday, Tuesday, Wednesday, Thursday and Friday and between the hours of 8 a.m. and 6.30 p.m. on Saturday in part of Dudley Road (eastern side) (Waiting limited to 30 minutes return prohibited within 1 hour).
