- 12577/80 (COM (80) 842). Proposal for a Council Regulation (EEC) maintaining the prices for fishery products fixed in Regulations (EEC) Nos. 2813/79, 2814/79, 2815/79 and 2816/79.
- 4698/81 (COM (81) 20). Proposals for a Council Regulation (EEC) laying down certain measures for the conservation and management of fishery resources applicable to vessels flying the flag of certain non-member countries in the 200 nautical-mile zone off the coast of the French Department of Guyana.
- 4692/81 (COM (81) 4). Proposals for Directives and a Decision concerning the right of establishment for certain activities in the field of pharmacy.
