CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: Mrs. Ruth Gabbe, Hausser Stre 17, 740 Tubingen, Germany.

24th March 1981

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely:

one gas pistol and six cartridges,

have been seized as liable to forfeiture upon the grounds that the said goods were imported at Weymouth Docks on or about the 21st day of September 1980 contrary to the prohibition for the time being in force with respect thereto by virtue of the Import of Goods (Control) Order 1954 made under the Import, Export and Customs Powers (Defence) Act 1939.

Whereby and by force of section 49 (1) (b) Customs and Excise Management Act 1979 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within 1 month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
