2 metres is substituted for 1.5 metres as the minimum length of a keepnet; 35 cm. x 30 cm. is substituted for 40 cm x 30 cm as the minimum size of rectangular stretching frames and no minimum distance apart is specified; meshes are required to be of knotless non-metallic material having holes of a minimum internal diameter of 6 mm. and a maximum internal diameter 25 mm. and forming not less than three-fifths of the total surface area of the net.
