

18. If an officer, rating or other rank is discharged for inefficiency within his own control or for misconduct then the award and amount of a resettlement grant shall be at the discretion of the Secretary of State for Defence providing that should an officer, rating or other rank be discharged for misconduct any resettlement grant payable under the provisions of this Schedule shall be abated by not less than 10 per cent. of the amount payable had the discharge been on other grounds.

19. Any resettlement grant awarded on release may be subject to partial refund on re-entry to the Service. The amount repayable will depend on the length of the break of service.

#### SCHEDULE XI

##### *Compensation for Criminal Injuries Sustained Overseas*

1. Payments under the provision of this Schedule are outside the scope of the Armed Forces Pension Scheme.

2. From 1st December 1979, when members of the armed forces and their eligible dependents, outside the United Kingdom by reason of service, sustain personal injury including death, directly attributable to a crime of violence they may be paid, *ex gratia*, a lump sum payment. Dependents will have the same meaning as in the provisions for forces family pensions. Whether or not to make such a payment, and if so, the amount, shall be wholly within the discretion of the Secretary of State for Defence. (1 S.I.)

7. Uniting the benefices and parishes of Ramsbottom and Shuttleworth, in the diocese of Manchester.
8. Vesting part of the churchyard of the parish church of Brundall, in the diocese of Norwich, in the Norwich Diocesan Board of Finance for disposal.

9. Uniting the benefices of Beaudesert with Henley-in-Arden; and Ullenhall and uniting the parishes of Beaudesert; and Henley-in-Arden, in the diocese of Coventry.

10. Uniting the benefices and parishes of Barnby on Don; and All Saints, Moss, in the diocese of Sheffield.

11. Uniting the benefices of Writtle and St. Paul, Highwood, in the diocese of Chelmsford.

12. Providing for the demolition of the redundant church of the Good Shepherd, Iping Marsh, in the diocese of Chichester, and appropriating its site to use as part of the annexed burial ground.

13. Appropriating the redundant church of St. Mary Magdalene, Langthorne, in the diocese of Ripon, and the annexed land to use for residential purposes, and empowering the said Commissioners to sell the said building and land for such use.

14. Appropriating the redundant church of The Assumption, Hardmead, in the diocese of Oxford, and the annexed land to use as a monument and empowering the Diocesan Board of Finance to lease the said building and land for such use.

15. Empowering the said Commissioners to sell the redundant church of St. Columb, Notting Hill, in the diocese of London, and the annexed land, to the Serbian Holy Orthodox Church.

16. (1) Demolishing parts of the redundant church of St. Michael, Sco' Ruston, in the diocese of Norwich and appropriating the remainder of the building and annexed land to use as a monument, and

(2) empowering the said Commissioners to give the said building and land for such use.
