CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely:

A B.M.W. 320 motor car registration No. DYL 786V have been seized as liable to forfeiture upon the grounds that:

(1) The supply of the said vehicle has been zero rated for VAT and car tax on the said vehicle has been remitted subject to the condition that the said goods were exported by the owner within 12 months of the date of delivery on 12th October 1979, which condition has not been complied with.
