#### *Importation of Animal Products and Poultry Products Order 1980 (As Amended)*

Notice is hereby given that as provided by Article 4 of the Importation of Animal Products and Poultry Products Order 1980, as amended, the Minister of Agriculture, Fisheries and Food and the Welsh Office Agriculture Department have issued the following general licences in accordance with the conditions attached to each licence as detailed below.

General Licences Nos. TAY/GEN/81/333 (in England) and WOAD/GEN/81/32 (in Wales) and TAY/GEN/81/334 (in England) and WOAD/GEN/81/33 (in Wales) and TAY/GEN/81/336 (in England) and WOAD/GEN/81/34 (in Wales) take effect from 1st June 1981, and replace General Licences Nos. TAY/GEN/80/209 (in England) and WOAD/GEN/80/5 (in Wales) dated 1st March 1980, which have been revoked.

A. Licence No. TAY/GEN/81/333 (in England) and WOAD/GEN/81/32 (in Wales).

Country: Northern Ireland

Subject of licence: Meat/offal intended for human consumption (derived from ruminating animals, swine, horse, ass, mule or hinny).

The licenses are valid for importation through:

- (a) all ports and airports in England, and
- (b) all ports and airports in Wales.

Conditions attached to licences above:

1. The meat/offal should bear a mark showing that it has been inspected and found fit for human consumption, and
2. The sealed container within which the meat/offal has been placed should be accompanied by one of the following Veterinary Certificates stating that the contents have been inspected and found fit for human consumption:

(a) a Certificate of Veterinary Inspection (under the Meat Shipping Regulations (Northern Ireland) (1964), or

(b) a certificate in accordance with EC Directive 64/433, or

(c) a veterinary certificate in compliance with a Third Country import requirement.

B. Licence No. TAY/GEN/81/334 (in England) and WOAD/GEN/81/33 (in Wales).

Country: Northern Ireland

Subject of licence: Unfit meat/offal derived from ruminating animals, swine, horse, ass, mule or hinny.

The licenses are valid for importation through:

- (a) all ports and airports in England, and
- (b) all ports and airports in Wales.

Conditions attached to licences above:

(1) The meat/offal must be accompanied by a certificate signed by a duly authorised veterinary officer of the Department of Agriculture for Northern Ireland stating that:

(a) the meat/offal is derived from animals slaughtered in an abattoir licensed for the production of meat for human consumption.

(b) The said animals received post-mortem inspection and showed no evidence of diseases listed in Annex E of EEC Directive 64/432.

(2) The meat/offal should be transported in sealed containers which bear a mark to the effect that the meat/offal is not intended for human consumption.

C. Licence No. TAY/GEN/81/336 (in England) and WOAD/GEN/81/34 (in Wales).

Country: Northern Ireland

Subject of licence: Animal products derived from ruminating animals, swine, horse, ass, mule, or hinny (excluding meat, offal and meat products).

The licenses are valid for importation through:

- (a) all ports and airports in England, and
- (b) all ports and airports in Wales.

These licenses are unconditional.
