## TREASURY SOLICITOR

Notice of Disclaimer under section 355 of the Companies Act 1948

#### Whereas:

(1) Pursuant to section 353 (5) of the Companies Act 1948 Arden Vale (Management) Company Limited (hereinafter called "the Company") became dissolved on 13th January 1970.

(2) It is alleged that immediately before such dissolution the property disclaimed by this notice was vested in the Company and may by virtue of section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

(3) It is desired to disclaim the Crown's Title (if any) to the property.

(4) That the property may have vested came to the notice of the Treasury Solicitor on 18th June 1981.

Now therefore I, the Treasury Solicitor, in exercise of the power in that behalf given by section 355 of the Companies Act 1948 do by this notice disclaim the. Crown's title (if any) to the property described in the Schedule hereto.

#### THE SCHEDULE

#### **Property Disclaimed**

The lease granted on 6th July 1964 by Newland Properties (Solihull) Ltd to the Company of certain land situate at the junction of Arden Vale Road and Warwick Road in Knowle, Solihull, Warwickshire, for 99 years from 29th September 1963 at a rent of £160 per annum. ## CUSTOMS AND EXCISE

#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: A.S.D. Stores Limited, 2 Boar Lane, Leeds, Yorkshire.

29th June 1981

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979, and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely

Five Sandasonic Walkie-Talkie radio sets, model No. 7703, manufactured in Hong Kong found in your possession or control

have been seized as liable to forfeiture upon the grounds that the importation of the said apparatus into the United Kingdom is prohibited by section 7 of the Wireless Telegraphy Act 1967 and the Radio Telephonic Transmitters (Control of Manufacture and Importation) Order 1968 save with the authority of the Post Master General, and you have been and are required to furnish proof to the satisfaction of the Commissioners of Customs and Excise that the importation of the said apparatus is or was not unlawful by virtue of section 7 of the said Act; and in the absence of such proof the said apparatus is deemed to be prohibited goods.

Whereby and by force of section 7 (5) of the Wireless Telegraphy Act 1967 and section 49 (1) (b) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act. In default of such notice the said goods will be deemed to have been
