*Notice of Disclaimer Under Section 355
of the Companies Act 1948*

Whereas:

(1) Pursuant to section 353 (5) of the Companies Act 1948 Brixton Holdings Ltd. (hereinafter called "the Company") became dissolved on 3rd April 1981.

(2) It is alleged that immediately before such dissolution the property disclaimed by this notice was vested in the Company and may by virtue of section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

(3) It is desired to disclaim the Crown's Title (if any) to the property.

(4) That the property may have vested came to the notice of the Treasury Solicitor on 15th April 1981.

Now therefore I, the Treasury Solicitor, in exercise of the power in that behalf given by section 355 of the Companies Act 1948 do by this notice disclaim the Crown's title (if any) to the property described in the Schedule hereto.

(40 MPH Speed Limit) Order 1981*

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 72 (3), 74 (1) and 84D of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

- (a) to prohibit the driving of motor vehicles at a speed exceeding 40 mph in the length of road described in Schedule 1 to this notice.
- (b) to revoke part of the Trunk Road (Built Up Areas) (No. 9) Order 1956 specified in Schedule 2 to this notice.

The Order will come into operation on 8th July 1981.

SCHEDULE 1

That length of the London-Holyhead Trunk Road (A5) at Bangor in the county of Gwynedd, which extends from a point 155 metres south of its junction with Penrhyn Avenue in a general northerly direction to a point 30 metres south of its junction with Port Penrhyn Road. A total distance of 504 metres.
