The route leaves the A47 trunk road 1½ km, west of the village centre and runs north-eastwards to cross Hodney Road in cutting just north of the existing road bridge over the disused railway. Response to the public consultation exhibition held at Leeds Hall, Eye, on 1st July 1980, showed strong support for a bypass. Two routes, a northern and a southern, were put forward for comment and two thirds of those who commented preferred the Northern Route which removes considerably more traffic from the village. This route was supported by the County and District Councils, although the Parish Council preferred the southern route. There was general concern about those who would be living close to a northern bypass, and those who would need to cross it to reach the main part of the village, and the detailed design of the road will seek to minimise these effects as far as possible effects as far as possible.

Further investigations will be carried out from which the design of the road, its detailed alignment and junction proposals, will be developed, leading to publication of draft Orders under the Highways Act, to which objections and representations can then be made.

In accordance with the provisions of section 192 (1) (f) of the Town and Country Planning Act 1971, the pre-ferred route will be protected from development. People whose property is blighted as a result may therefore serve a blight notice on the Secretary of State for Transport, if the statutory requirements are met.

The Department of Transport today announced the Long Northern Route as the preferred route for a bypass of Thorney, Cambridgeshire.

The route leaves the existing A47 trunk road 1.1 km. west of the village centre and crosses Station Road (the B1040) 350 metres to the north. It then runs in a straight line almost due east close to Old Wryde Drain, and rejoins the A47 at an existing sharp bend 3 km. east of the village centre. village centre.

Response to the public consultation exhibition held at the Village Hall, Thorney on 30th June 1980, showed strong support for a bypass. Three routes, a long northern, a short northern and southern, were put forward for comment. 56 per cent of those who commented preferred the long northern route, and 38 per cent the southern. Fewer than 6 per cent, supported the short northern route. The County, District and Parish Councils supported the long northern route. There was concern about residents who would be living near the bypass, the amount of

agricultural land required and the disruption to farming activities. The detailed design of the road will seek to

minimise these effects as far as possible.
