If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirements of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 22nd June 1981, apply to the High Court for this purpose.

The City of Peterborough (Residents Parking Places) Order 1981

Notice is hereby given that, pursuant to arrangements made with Cambridgeshire County Council, the Council of the City of Peterborough has made the above-named Order under sections 28 (1) and 31 (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

The effect of the Order, which comes into operation on 6th July 1981, is to authorise the use of parts of the roads specified in the Schedule to this notice as parking places for residents' vehicles during all the hours of any day. The Order also authorises the issue of a limited number of visitors' permits to residents.

A copy of the Order and a map showing the affected road are available at these offices where they may be examined at any time during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from the date of this notice, apply to the High Court for this purpose.
