Part I. Descriptions of Sites of Existing Paths

Those parts of the rights of way in the Parishes of Ropley and West Tisted in the District of East Hampshire shown on the Definitive Map of Public Rights of Way prepared under Part IV of the National Parks and Access to the Countryside Act 1949, as described below:

A. Ropley Footpath No. 27
