## ROAD TRAFFIC REGULATION ACT 1967, SECTION 12 (1)

The Trunk Road (Bromham Road, Bedford) (A428) (Temporary Prohibition and Restriction of Traffic) Order 1981

Notice is hereby given that the Secretary of State for Transport proposes to make an Order on the Felixstowe—Weedon Trunk Road (A428) at Bromham Road in Bedford.

The Order, which is being made to enable works to be carried out, will be in operation when the appropriate signs are erected, from 24th July 1981 until such time as the works have been completed.

The effect of the Order will be:

(a) to close that length of the trunk road known as Bromham Road, Bedford which extends from its junction with Conduit Road to its junction with Roise Street from 24th July until he evening of 26th July;

(iii) to prohibit the overtaking of any moving vehicle in the said length of trunk road;
(iv) to cause traffic to travel in a north to south direction, i.e. towards Bromham Road, in that length of Union Street which extends from its junction with Trevor Street to its junction with the trunk road;

(v) to cause traffic to travel in a south to north direction in Shakespeare Road, i.e. from Bromham Road towards Clapham Road.

Whilst complete closure takes place eastbound traffic will be diverted via Shakespeare Road, Clapham Road (A6), Tavistock Street (A6) and the Broadway to rejoin the A428 at St. Peter's Street, Westbound traffic will be diverted via Harpur Street, Tavistock Street, Clapham Road and Shakespeare Road.

When one-way working is in operation westbound traffic will use the normal route and eastbound traffic will con-

tinue to use the diversion route.

From 24th July northbound traffic on the A6 will be diverted from Greyfriars via Hassett Street, Bromham Road, St. Loyes Street, Dame Alice Street and Harpur Street.

Any vehicle being used in connection with the said works, or for police, fire brigade or ambulance purposes will be exempt from the prohibitions contained in the Order.
