*The Counties of Mid Glamorgan and Gwent (Public Footpath No. 337 in the Community of Bedwas and Machen and Public Footpath Nos. 3 and 29 in the Community of Lower Machen) Diversion Order 1981.*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 16th June 1981, is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the Mid Glamorgan County Council and the Gwent County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public rights of way more particularly described in Part I of the Schedule annexed hereto and to create alternative highways more particularly described in Part II of the Schedule annexed hereto.

A copy of the Order and the map contained therein has been deposited at the offices of the Mid Glamorgan County Council, Mid Glamorgan County Hall, Cathays Park, Cardiff CF1 3NE, the Gwent County Council, County Hall, Cwmbran, Gwent NP44 2XH, the Rhymney Valley District Council, Council Offices, Park Road, Hengoed, and at the offices of the Newport Borough Council, Civic Centre, Newport, and may be inspected free of charge during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the County Clerk and Co-ordinator of the Mid Glamorgan County Council, Mid Glamorgan County Hall, Cathays Park, Cardiff CF1 3NE, not later than 10th August 1981, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Mid Glamorgan County Council and the Gwent County Council may, instead of submitting the Order to the Secretary of State for Wales for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

PART I

*Description of Site on Existing Highways*

*Public Footpath No. 337 in the Community of Bedwas and Machen in the County of Mid Glamorgan*

That length of public footpath No. 337 in the Community of Bedwas and Machen commencing at a point 280 metres (310 yards) or thereabouts, north-east of Ffwrwm and which proceeds in a south-easterly direction for a distance of 245 metres (270 yards) or thereabouts to its termination on the County Boundary and shown on the plan deposited in a bold black line between points A-B.

*Public Footpath No. 3 in the Community of Lower Machen in the County of Gwent*

That length of public footpath No. 3 in the Community of Lower Machen from a point on the County Boundary and which proceeds in a south-easterly direction for a

distance of 92 metres (100 yards) or thereabouts and shown on the plan deposited in a bold black line between points B-E.

*Public Footpath No. 29 in the Community of Lower Machen in the County of Gwent*

That length of public footpath No. 29 in the Community of Lower Machen from a point on the County Boundary and which proceeds in a southerly, south-westerly and easterly direction for a distance of 360 metres (390 yards) or thereabouts and shown on the plan deposited in a bold black line between points C-E-F-G.

PART II

*Description of Site of Alternative Highways*

The length of alternative route to be created to replace that section of public footpath No. 337 in the Community of Bedwas and Machen to be a 1.4 metres (4ft. 6ins.) wide footpath from a point 280 metres (310 yards) or thereabouts north-east of Ffwrwm, and proceeding in a mainly north-easterly and south-easterly direction to its termination on the County Boundary, a total distance of 400 metres (440 yards) or thereabouts and shown on the plan deposited in a broken black line between points A-D-C.

That length of alternative route to be created to replace those sections of public footpaths Nos. 3 and 29 in the Community of Lower Machen to be 1.4 metres (4ft. 6ins.) wide footpath from a point on the County Boundary and proceeding in a mainly south-easterly, south-westerly and southerly direction for a distance of 369 metres (400 yards) or thereabouts and shown on the plan deposited in a broken black line between points C-H-G.

*The Ryedale District Council (Wigginton No. 10) Public Path Diversion Order 1979*

Notice is hereby given that the above-named Order made on 9th July 1981 is about to be submitted to the Secretary of State for the Department of the Environment for confirmation or to be confirmed by the Ryedale District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert part of the public right of way running in a south-easterly direction from the corner of field O.S. 0064 on O.S. Sheet Nos. SE 5957 and SE 6057 (1969 and 1967 Edition) to join the beck on the eastern side of Westfield Lane, Wigginton, York in the County of North Yorkshire, and create an alternative public footpath in lieu.

If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
