The Trunk Roads (A66 and A19) (24 Hour Main Carriageway Clearway) Order 1981

The Secretary of State for Transport has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 on the Penrith—Middlesbrough and East of Snaith—Sunderland Trunk Roads (A66 and A19) in the boroughs of Stockton-on-Tees and Middlesbrough in the County of Cleveland.

The effect of the Order, which comes into operation on 14th July 1981, is to prohibit waiting on any of the main carriageways (including the carriageways of the slip roads) forming part of:

- (a) the trunk road (A66) between a point 200 metres west of Yarm Back Lane and Durham Lane (C138) and a point 260 metres east of the bridge over the Old River Tees; and
- (b) the trunk road (A19) between its junction with the southern slip roads at Parkway Interchange and its junction with the north-western slip roads at Haverton Hill Interchange.

The prohibition will not apply:

- (a) to a vehicle waiting upon the direction or with the permission of a police constable in uniform or of a traffic warden;
- (b) so as to prevent a vehicle from being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or of any of the services therein;
- (c) to a vehicle being used for police, ambulance or fire brigade purposes;
- (d) to a vehicle being used in the service of a local authority or of a water authority in pursuance of statutory powers or duties; or

(e) to a vehicle waiting when the person in control of it is:

- (i) required by law to stop;
- (ii) obliged to stop to avoid an accident; or
- (iii) prevented from proceeding by circumstances outside his control.

EASTBOURNE BOROUGH COUNCIL

The Borough of Eastbourne (Grove Road) (Experimental) Traffic Regulation Order 1981
