ROAD TRAFFIC REGULATION ACT 1967

AS AMENDED BY PART IX OF THE TRANSPORT ACT 1968

The Trunk Road (40 m.p.h. Speed Limit) (No.) Order 198

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 74 (1) and (2) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on that length of the Hungerford-Hereford Trunk Road (A49) at Peterstow, in the County of Hereford and Worcester, which extends from a point 14 metres north-west of its junction with the UC728 road to a point 34 metres south-east of its junction with the UC730 road, a distance of approximately 594 metres.

A copy of the proposed Order together with a plan illustrating the proposal and a statement explaining the Secretary of State for Transport's reason for proposing to make the Order may be inspected during office hours, at the offices of the South Herefordshire District Council, Brockington, 35 Hafod Road, Hereford HR1 1SH; Hereford and Worcester County Council, County Hall, Spetchley Road, Worcester WR5 2NP and at the offices of the Regional Controller (Roads and Transportation).
