SUFFOLK COUNTY COUNCIL

Suffolk County Council (Parish of Horringer) (Abbotsbury Road, Glastonbury Road and Romsey Road) (Prohibition of Waiting) Order 1981.

Notice is hereby given that on 14th July 1981 the Suffolk County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit the waiting of vehicles on the sides of roads specified in the Schedule hereto.

Exceptions in the Order provide for a vehicle to wait on the roads specified for as long as may be necessary for a person to board or alight, to enable goods to be loaded or unloaded, to enable it to be used in connection with any building or demolition operation and the maintenance of the road or the services therein.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any of the requirements of that Act or of any instrument made under it have not been complied with in relation to the Order you may within 6 weeks of the date on which the Order was made apply to the High Court for this purpose.

Surrey County Council (Gloucester Road and Freemantle Road) Bagshot (Prohibition of Cycling) Order 1981
