The Hartlepool Borough Council (Osborne Road Area) (Restriction of Waiting) Order 1981

- (d) *Dalton Street*, south side, from its junction with Osborne Road for a distance of 18 metres in an easterly direction.
- (e) *Stanhope Avenue*, south side, from its junction with Osborne Road for a distance of 15 metres in a westerly direction.
