A Statute made by the University of Cambridge, on 22nd July 1981, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923. (1 SI)

PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on 31st July 1981 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Barholme with Stowe; Gretford; Tallington; Uffington; West Deeping, in the diocese of Lincoln.

2. Uniting the benefices of Churcham with Bulley; and Minsterworth, in the diocese of Gloucester, and disposing of the Minsterworth parsonage house and its grounds.

3. Uniting the benefices and parishes of Great Amwell; and Stanstead St. Margaret, in the diocese of St. Albans.

4. Uniting the benefices of Combe Down with Monkton Combe; South Stoke, in the diocese of Bath and Wells.

5. Uniting the benefices of Hatherden with Tangley; and Weyhill with Penton Mewsey, in the diocese of Winchester.

6. Uniting the benefices of Hardington Mandeville with Pendomer; and East Chinnock, in the diocese of Bath and Wells.

7. (1) Transferring the parish of South Charlton from the benefice of Ellingham with South Charlton to the benefice of the Wooler Group; (2) uniting the benefices of Beadnell and Ellingham with South Charlton; (3) uniting the benefices of Eglingham and the Wooler Group, and establishing a team ministry for the area of the benefice of the Glendale Group, in the diocese of Newcastle.

8. Vesting part of a burial ground situated in the parish of Bisley, in the diocese of Gloucester in the Gloucester Diocesan Board of Finance Limited for disposal.

9. Declaring redundant the parish church of St. George, Barnsley, in the diocese of Wakefield.

10. Transferring the parish of Brompton Ralph from the benefice of Monksilver with Brompton Ralph and Nettlecombe to the benefices of Lydeard St. Lawrence with Combe Florey and Tolland; uniting the benefices of Stogumber and Monksilver with Brompton Ralph and Nettlecombe; and uniting the benefices of Lydeard St. Lawrence with Combe Florey and Tolland; and Ash Priors, in the diocese of Bath and Wells.

11. Uniting the parishes of Spaxton and Charlynch and declaring redundant the parish church of the parish of Charlynch, in the diocese of Bath and Wells.

12. Uniting the benefices of Rogate; Terwick; and Trotton with Chithurst and uniting the parishes of Rogate and Terwick, in the diocese of Chichester.

13. Uniting the benefices of Fylingdales; and All Saints, Hawsker and altering the name of the parish of All Saints, Hawkser, in the diocese of York.

14. Appropriating part of the detached burial ground of the benefice of Clewer as diocesan glebe land of the diocese of Oxford.

15. Uniting the benefices of White Notley with Faulkbourne; and Cressing, in the diocese of Chelmsford.

16. (1) Providing for a new place of worship for the parish of Christ Church, West Green with St. Peter, in the diocese of London; (2) declaring redundant the existing parish church; and (3) providing for the demolition of the redundant church and the disposal of its site and annexed land.

17. Uniting the benefices and parishes of St. Barnabas, Homerton; and St. Paul, Lower Homerton, and declaring redundant the parish church of the parish of St. Paul, Lower Homerton, in the diocese of London.

18. Uniting the benefices of Colaton Raleigh; and Otterton, in the diocese of Exeter.

19. Uniting the benefices of Leake and Wrangle, and altering the name of the parish of Leake, in the diocese of Lincoln.
