

20. Uniting the benefices of Preston with Sutton Poyntz; and Osmington with Poxwell, and establishing a team ministry for the new benefice, in the diocese of Salisbury.

21. Uniting the benefices of Clifton-on-Teme; Lower Sapey; and The Shelsleys, in the diocese of Worcester.

22. Uniting the benefices of Leighton Buzzard, Eggington, Hockliffe, and Billington, in the diocese of St. Albans.

23. Uniting the benefices of Christ Church, Appleton-le-Moors; and Lastingham, in the diocese of York.

24. (1) Creating a new benefice and parish of Woodcote, in the diocese of Oxford; (2) altering the name of the benefice and parish of South Stoke with Woodcote; (3) uniting the benefices of Checkendon; Stoke Row; and Woodcote; and (4) establishing a team ministry for the area of the new benefice.

25. Establishing a team ministry for the area of the benefice of Moulsecocomb, in the diocese of Chichester.

26. Appropriating part of the churchyard of the church of St. Matthew, West Ham, in the diocese of Chelmsford, to use as a site for a team vicar's house and garden.

27. Creating a new benefice and parish of Allerthorpe; uniting the benefices of Seaton Ross with Everingham and Bielby and Harswell; and Thornton with Allerthorpe; and altering the name of the parish of Thornton with Allerthorpe, in the diocese of York.

28. Uniting the benefices of Claypole; and Westborough with Dry Doddington and Stubton, in the diocese of Lincoln.

29. Appropriating the detached burial ground in the parish of Whitechurch with Tufton and Litchfield, in the diocese of Winchester to use as a public burial ground.

30. Creating a new benefice and parish of St. Paul, The Apostle, Croxeth and altering the areas of the parishes of The Good Shepherd, West Derby and West Derby, in the diocese of Liverpool.

31. Creating a new benefice and parish of Northampton St. Benedict, and altering the areas of the parishes of Wootton and St. Mary and Virgin, Northampton, in the diocese of Peterborough.

32. Uniting the parishes of Scamblesby and Calkwell and uniting the benefices of Asterby with Goulceby; Benniworth with Market Stainton and Ranby; Burgh on Bain; Donington on Bain; Gayton le Wold with Biscathorpe; Scamblesby with Calkwell; and Stenigot, in the diocese of Lincoln.

33. Uniting the benefices of Hawkshead and Low Wray; and St. Peter, Sawrey, in the diocese of Carlisle.

34. Uniting the benefices of Ingleby Greenhow; and Bilsdale, in the diocese of York, and altering the name of the parish of Bilsdale.

35. Establishing a team ministry for the benefice of St. John, Selsdon; and altering the name of the benefice and parish of St. John, Selsdon, in the diocese of Canterbury.

36. Uniting the benefices of St. Peter, Priors Lee; and St. George, Pain's Lane and altering the areas of the parishes of St. Peter, Priors Lee; St. George, Pain's Lane; St. Matthew, Donnington Wood; Oakengates; and Wrockwardine-Wood, in the diocese of Lichfield.

37. (1) Uniting the benefices of Whitechurch and Oving with Pitchcott; Hoggston with Dunton; Hardwicke; North Marston and Granborough; and Quainton; (2) uniting the parishes of Oving and Pitchcott; and (3) establishing a team ministry for the area of the new benefice, in the diocese of Oxford.

38. Uniting the benefices of Shipdham; and East Bradenham with West Bradenham, in the diocese of Norwich.

39. Uniting the benefices of Bromsberrow; and Redmarley D'Abitot with Pauntley, Upleadon and Oxenhall, in the diocese of Gloucester.

40. Uniting the benefices of Markham Clinton, Tuxford, and Weston, in the diocese of Southwell.

41. Uniting the benefices of Orton with Tebay; and Ravenstonedale with Newbiggin-on-Lune, in the diocese of Carlisle.

42. Uniting the benefices of Bramley; and St. Andrew, Grafham, in the diocese of Guildford.

43. Appropriating part of the churchyard of St. George, Everton, in the diocese of Liverpool, as a site for the incumbent's residence and garden.

44. Uniting the benefices of Harlaxton and Wyville with Hungerton; Denton; and Stroxtan, in the diocese of Lincoln, in substitution for a previous Scheme.

45. Holding the benefices of Greystoke, Matterdale and Mungrisdale; and Watermillock in plurality; and extending the operation of the team ministry established for the area of the benefice of the former to the area of the latter benefice, in the diocese of Carlisle.

46. Making the Redundant Churches Fund responsible for the care and maintenance of the redundant church of St. Mary, Bungay, in the diocese of St. Edmundsbury and Ipswich.

47. Appropriating the redundant church of St. James, Crownthorpe, in the diocese of Norwich, to use as a rural craft workshop; and empowering the Diocesan Board of Finance to lease it for such use.

48. Providing for the demolition of the redundant church of Christ Church, Blackpool, in the diocese of Blackburn; and empowering the said Commissioners to dispose of its site and the annexed land.

49. Appropriating the redundant church of St. John, East Heckington, in the diocese of Lincoln, and part of the annexed land to use for residential purposes, and empowering the said Commissioners to sell the said building land for such use.

50. Appropriating the redundant church of St. Peter, Parmentergate, Norwich, in the diocese of Norwich, and the annexed land to use for civic, public, educational or storage purposes, and empowering the Commissioners to give the said building and land for such use.

51. Providing for the demolition of the redundant church of St. Saviour, Preston, Brighton, in the diocese of Chichester; and empowering the said Commissioners to sell or lease its site and the annexed land.

52. Appropriating the redundant church of St. Wulstan, Selly Oak, in the diocese of Birmingham and the annexed land to use for religious activities in accordance with the rites and customs of the Elim Pentecostal Church and empowering the said Commissioners to give the said building and land for such use.

53. Appropriating the redundant church of St. James, Camberwell, in the diocese of Southwark, and the annexed land to use for residential purposes, and empowering the Diocesan Board of Finance to lease the said building and land for such use.

54. Appropriating the redundant church of St. Mary Magdalen, Hastings, in the diocese of Chichester, and part of the annexed land to use for religious activities in connection with the Greek Orthodox Church and empowering the Commissioners to sell the said building and its land for such use.

55. Appropriating the redundant church of St. Paul, Alnwick, in the diocese of Newcastle, and the annexed land to use for religious purposes by the Roman Catholic Church; and empowering the said Commissioners to sell the said building and land for such use.

56. Appropriating the redundant church of All Souls, Witton, in the diocese of Birmingham, and the annexed land to use for religious activities in accordance with the rites and customs of the Church of God (Universal), and empowering the said Commissioners to sell the said building and land for such use.
