

(b) Paragraph 3 of the second Schedule and paragraph 20 of the third Schedule of the Borough of Hemel Hempstead (Traffic Regulation No. 1) Order 1962, as amended by the Borough of Hemel Hempstead (Traffic Regulation No. 1) Order 1964.

(c) Paragraph 8 of the First Schedule of the Borough of Hemel Hempstead (Various Roads) Traffic Regulation Order 1973.

(2) Waiting will be prohibited at any time on the south side of Bridge Street, Hemel Hempstead, between Marlowes and Waterhouse Street.

(3) Waiting will be restricted to not more than 60 minutes in any two hours between 8.30 a.m. and 6.30 p.m. Mondays to Saturdays on the west side of Marlowes, Hemel Hempstead from a point 45 yards (41 metres) north of Moor End Road to a point 28 yards (26 metres) to the north of that point.

Exemptions will be provided in (2) and (3) above, for the purpose of:

- (a) taking up and setting down passengers;
- (b) loading or unloading goods;
- (c) emergency service vehicles;
- (d) disabled persons' vehicles;

and where necessary, in connection with:

- (e) maintenance of roads;
- (f) supply of gas, water and electricity;
- (g) the delivery and collection of postal packets.

The Order will operate for an experimental period of 6 months in conjunction with proposals to move the existing Hackney Carriage rank outside Quality House on the west side of Marlowes to the south side of Bridge Street. The Order will be extended for a further period of 6 months or indefinitely should this be necessary.

Full details of the proposals are in the draft Order, which, together with a plan showing the lengths of road affected and statement of the Council's reasons for proposing to make the Order, may be examined during normal office hours at the Dacorum Civic Centre, Marlowes, Hemel Hempstead.

Any objections to the proposed Order must be sent in writing, together with the grounds on which they are made, to be received by the undersigned not later than 14th September 1981.

The Dacorum District Council (Various Roads) (Prohibition and Restriction of Waiting) (No. 3) Order 1981

Notice is hereby given that the Dacorum District Council, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Hertford in exercise of the powers of the said County Council under section 1 (1), (2) and (3) and 84D of the Road Traffic Regulation Act 1967, as amended, hereby give notice of their intention to make a Traffic Regulation Order with the following effect:

- (1) vehicles will be prohibited from waiting at all times on the lengths of road shown in the First Schedule to this notice.
- (2) vehicles will be prohibited from waiting between the hours of 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of road shown in the Second Schedule to this notice.
- (3) vehicles will be prohibited from waiting between the hours of 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive for a longer period than 60 minutes in any consecutive period of two hours in any of the lengths of road specific in the Third Schedule to this notice.
- (4) the previous Orders and parts of Orders specified in the Fourth Schedule to this notice will be revoked.

Exemptions in the proposed Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods;
- (c) emergency service vehicles;
- (d) disabled persons' vehicles;

and where necessary in connection with:

- (e) the maintenance of the road;
- (f) supply of gas, electricity and water;
- (g) the delivery and collection of postal packets.

Full details of the proposals are in the draft Order, which, together with the plans showing the lengths of road affected and statement of the Council's reasons for proposing to make the Order, may be examined during normal office hours at the Dacorum Civic Centre, Marlowes, Hemel Hempstead, or at the Council's branch offices at the Civic Centre, High Street, Berkhamsted.

(1) Marlowes, Hemel Hempstead, east side:

(a) From the junction with Queensway to 2.2 yards (2 metres) north of the southern boundary of No. 5 Marlowes.

(b) From the northern boundary of No. 21 Marlowes to 7.6 yards (7 metres) south of No. 33A.

(2) Leverstock Green Community Centre Access Road, Hemel Hempstead, both sides, for 44 yards (40 metres) from Leverstock Green Road in a north-east direction.

(3) Long Chaulden Shopping Centre Exit Road, Hemel Hempstead, south-west side for 49 yards (45 metres) from the junction with Long Chaulden in a north-east direction.

(4) *The Nokes*, Hemel Hempstead, north-east side for 46 yards (42 metres) from the junction with Galley Hill in a north-west direction.

SCHEDULE 2

(1) Longlands, Hemel Hempstead, east side, from Hammer Lane to a point 14 yards (13 metres) north of the centre line of the Queens Square.

(2) *Manor Close*, Berkhamsted, both sides for 16 yards (15 metres) from its junction with Castle Street.

Waiting Restricted to 60 minutes in 2 hours, 8.30 a.m. to 6.30 p.m., Mondays to Saturdays inclusive

Marlowes, Hemel Hempstead, east side, from 2.2 yards (2 metres) north of the southern boundary of No. 5 Marlowes to the northern boundary of No. 21.
