

SOUTH GLAMORGAN COUNTY COUNCIL

New Traffic Proposals for the County of South Glamorgan

Notice is hereby given that the County Council of South Glamorgan, in exercise of its powers under the Road Traffic Regulation Act 1967, as amended, intends imposing traffic restrictions on the lengths of road referred to in column 1 of the Schedule below. The nature of the restriction is shown in column 2 and the titles of the proposed Orders are shown in column 3.

Exemptions to the restrictions marked with an asterisk (*) will be permitted for boarding and alighting from a vehicle; loading and unloading of goods; essential services and funerals; for a maximum of two hours, vehicles when displaying "Orange Badge" and being used for the conveyance of a disabled person.

Full details of the proposals and plans showing the location and extent of the proposed restrictions, may be seen at the address shown below during normal office hours. Details of the Penarth proposal may also be seen at Penarth Library, Stanwell Road, Penarth.

Any objection you may have to any of the proposals must be submitted to me in writing by 19th October 1981 and must contain the grounds on which you object.
