NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely:

One handgun serial number 2530092

have been seized as liable to forfeiture upon the ground(s) that the said goods were imported into the United Kingdom at London Heathrow Airport on or about the 20th December 1980 contrary to the prohibition imposed by the Import of Goods (Control) Order 1954. Whereby and by force of section 3 (1) of the Import, Export and Customs Powers (Defence) Act 1939 and section 49 (1) (b) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture. If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in England and Wales who is

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an order under section 209 of the above Act entitled "The Stopping up of Highways (County of North Yorkshire) (York No. 1) Order 1981", authorising the stopping up of lengths of Bedern, York, and requiring the provision of a new highway and a new footpath.
