#### **BRITISH TELECOMMUNICATIONS ACT 1981** (c. 38)

### Licence under Section 68

The Secretary of State, in exercise of the power conferred on him by section 68 of the British Telecommunications Act 1981 and after consultation with the Post Office, hereby grants to any charity and to the persons specified in paragraph 2 below and subject to the conditions specified in paragraph 3 below and to revocation as specified in paragraph 4 below, a licence for the conveyance of Christmas cards from one place to another.

- 2. The persons referred to in paragraph 1 above are a trustee, an officer or an employee of a charity or any other person authorised b ya charity to act on its behalf for the purpose of such conveyance.
- 3. The conditions referred to in paragraph 1 above are that the said conveyance shall be carried out only:
  - (a) for the purpose of raising funds for, or otherwise in connection with the charitable purposes of, the charity by, for or to whom the Christmas cards in question are conveyed;
  - (b) during the period beginning on 25th November in any year and ending on 1st January in the following
  - (c) in a case where the conveyance is carried out by a person authorised as mentioned in paragraph 2 above, either

(i) when he is acting otherwise than in the course

of a business, or

(ii) if he is acting in the course of a business, to the extent only that the Christmas cards in question are received or collected by him from premises occupied by the charity for whom they are conveyed and are delivered by him to that or another charity or other charities at other premises occupied by any of those charities.

- 4. This licence shall cease to have effect:
- (a) in respect of all charities and persons to whom it applies, immediately following the last of the dates on which a notice to that effect given by the Secretary of State is published in the London, Edinburgh and Belfast Gazettes; and
- (b) in respect of any charity or person to whom it applies who is given written notice to that effect by the Secretary of State, on the date specified for that purpose in the notice.
- 5. For the purposes of this licence:
- (a) "Christmas card" means a document which conveys a greeting appropriate to the seasons of Christmas and the New Year (or either of them) and no other communication relating to the personal, private or business affairs of any person; and
- (b) "charity" means any body of persons or trust estab-lished for charitable purposes only,

and references to the conveyance of Christmas cards include references to the performance of all the incidental services of receiving, collecting and delivering them.

6. Subject to paragraph 4 above, this licence shall continue in force from the date hereof until midnight on

1st January 2007.
