The Order becomes operative as from 16th December 1981, but if any person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of the Act as amended or of any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 2 of Schedule 6 to the Act within 6 weeks from 6th January 1982, make an application for the purpose to the High Court.
