#### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's Office (Bank Buildings) at the Bank of England on Friday, 15th January 1982 at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of  $\pounds 5,000$ ,  $\pounds 10,000$ ,  $\pounds 25,000$ ,  $\pounds 50,000$ ,  $\pounds 100,000$ ,  $\pounds 250,000$  or  $\pounds 1,000,000$ . They will be dated at the option of the tenderer on any business day from Monday, 18th January 1982 to Friday, 22nd January 1982 inclusive and will be due 91 days after date.
