**PORTSMOUTH CITY COUNCIL**

*The Portsmouth (Alverstone Road) (Experimental Prohibition of Driving and Waiting) (No. 2) Order 1982*

Notice is hereby given that the Portsmouth City Council propose to make the above Order under the Road Traffic Regulation Act 1967, as amended. The effect will be as follows:

**A. Experimental Prohibition of Driving**

*Alverstone Road*, the northern section of Alverstone Road will be blocked off opposite No. 92 as an experiment, to remove the high volume of through traffic which currently uses the residential roads to the south.

**B. Experimental Prohibition of Waiting**

As part of the exercise, prohibition of waiting restrictions will be introduced to keep the road closure free from parked vehicles.

**SOUTH RIBBLE BOROUGH COUNCIL**

*The Borough Council of South Ribble (North View, Leyland) (Restriction of Waiting) (Revocation) Order 1982*

Notice is hereby given that the Borough Council of South Ribble, acting under the Agency Agreement with Lancashire County Council, proposes to make an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, by Part IX of the

**SUFFOLK COUNTY COUNCIL**

*Suffolk County Council (Parish of Felixstowe) (Various Streets) (One Way Traffic Prohibition of Right Hand Turn and Restriction of Waiting) Order 1982.*

Notice is hereby given that on 12th January 1982 the Suffolk County Council made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended, the effect of which is to:

(i) impose one-way traffic flow in the roads specified in Schedule 1 to this notice, and

(ii) restrict the waiting of vehicles on the side of road specified in Schedule 2 to this notice.

The proposals are currently operating satisfactorily on an experimental basis.

Where the proposals conflict with existing restrictions, the relevant Orders were revoked appropriately.

Exceptions in the Order provide for a vehicle to wait on the roads specified in Schedule 2 for so long as may be necessary for a person to board or alight, to enable goods to be loaded or unloaded, to enable it to be used in connection with any building or demolition operation and the maintenance of the road or the services therein.

A copy of the Order which becomes operative on 25th January 1982 and a map showing the roads affected, are available for inspection until 24th February 1982 during normal office hours at the Suffolk Coastal District Council Offices, Town Hall, Felixstowe, and my office.

If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended, or on the grounds that any of the requirements of that Act or of any instrument made under it have not been complied with in relation to the Order, you may within 6 weeks of the date on which the Order was made apply to the High Court for this purpose.
