- (a) A route (the main route) about 6-63 kilometres in length which he proposes to construct at Holywell in the County of Clwyd.
- (b) Routes for slip roads to connect the main route with the existing Classified Roads to Pen-ffordd-llan and Caerwys.

2. An Order under sections 12, 14 and 125 of the High-ways Act 1980 the effect of which is to:

(a) authorise him:
