(a) Motor Cycles A marked bay situated on the West Side of the access road extending from the southern extremity of the road northwards for a distance of approximately 22 metres. There is no proposal for any limitation as to the period of waiting.

(b) Disabled Drivers

An area comprising 4 marked bays immediately adjoining the eastern elevation of the Library building. These bays will also be subject to a maximum period of waiting of 2 hours.

Exemptions to the Order will permit waiting for certain purposes including building operations, road and similar works and the parking of mobile library vehicles on the lengths of road adjoining the library building. There will be no exemption for vehicles being driven by or conveying Disabled Drivers to wait in the areas other than the bays specified in (ii)(b) above.
