ROAD TRAFFIC REGULATION ACT 1967 SECTION 12

Notice is hereby given that the Secretary of State for Transport has made an Order affecting the West of Maidenhead-Oxford Trunk Road (A423) in the District of Windsor and Maidenhead in the Royal County of Berkshire.

The effect of the Order is to prohibit vehicles using the A423 trunk road (Henley Road) between the roundabout with the A4 at Maidenhead Thicket and the roundabout with the A404 at Burchett's Green a distance of 2.1 kilometres, during the period commencing at 0500 hours on Friday, 5th February 1982, and ending when the works have been completed.

The Order is necessary to allow for major maintenance works on the carriageways to be carried out.

The alternative route for north-westbound traffic will be from the A423/A4 junction at Maidenhead Thicket, westwards via the A4 to Knowl Hill then northwards via the A404 to rejoin the A423 at Burchett's Green. The alternative route for south-eastbound traffic will be the same route in the opposite direction.

At such time as the carriageways are closed to through traffic provision will be made for vehicles wishing to gain access to and from properties in Henley Road (A423).
