ABSTRACT WATER

NOTICE OF APPLICATION TO VARY A COMBINED  
LICENCE TO IMPOUND AND ABSTRACT WATER  
FROM AN INLAND WATER.

Notice is hereby given that an application is being made to the Anglian Water Authority, Essex River Division, by the Trustees of Rochford Angling Club to vary licence number 8/37/42/19 which permits two ditch tributaries of the Beeches Brook to be impounded at Hullbridge Road, Rayleigh, Essex, at National Grid Map Reference TQ 811 928 and to abstract therefrom an initial quantity of 20,000 cubic metres of water during the periods 1st November 1980 to 31st March 1981, and 1st November 1981 to 31st March 1982 and thereafter 5,000 cubic metres of water during each period beginning 1st November and ending 31st March following. The water abstracted is to be used to fill and maintain the level of water in a fishery reservoir.

The variation applied for is:

- (1) To include impounding works at National Grid Map Reference Point TQ 809 929.
- (2) To allow abstraction from an existing pond at National Grid Map Reference TQ 810 929 adjacent to the reservoir, by means of a pump of a capacity not exceeding 3,000 gallons per hour.
- (3) To extend the period of initial filling of the reservoir to include the period 1st April 1982 to 31st May 1982.
