**LIVERPOOL CITY COUNCIL  
CLEAN AIR ACT 1956**

*The City Council of Liverpool (No. 37) Smoke Control Order 1982*

Notice is hereby given that the Liverpool City Council in exercise of the powers conferred on them by section 11 of the above-mentioned Act, as amended by the Local Government Planning and Land Act 1980, proposes to make an Order entitled "The City of Liverpool No. 37 Smoke Control Order 1982", declaring the area described in the Schedule hereto to be a smoke control area.

Subject to the limitations and exemptions provided by the Order and by virtue of section 11 (2) of the Act, if on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the proposed smoke control area, the occupier of any building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

A copy of the proposed Order and the map referred to therein may be inspected free of charge at Room 216, Second Floor, Municipal Buildings, Dale Street, Liverpool 2, at all reasonable times during the period of 6 weeks from 10th February 1982.

**ROAD TRAFFIC ACTS**

**CAMBRIDGE CITY COUNCIL**

*Road Traffic Regulation Act 1967*

Notice is hereby given that Cambridge City Council acting in pursuance of arrangements made under section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under sections 1, 28, 31, 35, 36, 37, 39 and 84D (1) of the Road Traffic Regulation Act 1967 as amended proposes to make the orders given below.

The Orders and their effects are as follows:

1. *The Parking Places and Controlled Parking Zone (Cambridge) Order 1971 (Variation No. ) Order 198 .*

To relax the existing 24 hour waiting prohibitions on the south side of King Street from a point 123.2 metres west of its junction with Short Street westwards for 20 metres and from a point 174.4 metres west of its junction with Short Street westwards for 20 metres, so that in each of these two lengths of road waiting is prohibited only from 8.30 a.m. to 6.30 p.m. (Mondays to Saturdays inclusive).
