#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To: Confeccoes Rainha do Ave, Rua Joaquim da Costa Pereira Serra, Trofa-Minho, Portugal. 10th March 1982

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and any enactments amending those Acts, certain goods, namely:

140 cartons of 100 per cent cotton sweat shirts imported at Erith Kent on 22nd June 1981 and entered by Allport Freight Ltd. to entry number 150 5314 of 26th June 1981 have been seized as liable to forfeiture upon the ground(s) that:

the said goods were found not to correspond with the entry made thereof in that the entry declared that there were 3,500 sweat shirts in the cartons whereas in fact there were 7,000 sweat shirts.

Whereby and by force of section 49 (1) (e) of the Customs and Excise Management Act 1979 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in United Kingdom who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
