BASILDON DISTRICT COUNCIL

BASILDON DISTRICT COUNCIL TRAFFIC ORDERS

Notice is hereby given that the District Council of Basildon, pursuant to arrangements made with the County Council of Essex under section 101 of the Local Government Act 1972, and in exercise of the powers of the said County Council under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974 intend to make the following Traffic Orders:

The District of Basildon (Town Centre, Basildon) (Waiting Restriction) (Amendment) Order 1982

To remove the exemption from the present waiting restrictions for goods vehicles to be parked outside the operations of loading and unloading in the service road to the rear of Keay House, and Market Pavement Basildon Town Centre.

The District of Basildon (Pitsea Broadway) (Traffic Regulation) Order 1982

To introduce a one-way circulatory system over the length of High Road, Pitsea between the roundabout at the junction of Station Lane and Rectory Park Drive, Pitsea.
