NOTICE OF PROPOSAL TO MODIFY A PUBLIC PATH ORDER

The Borough of Dartford Public Path Diversion Order 1979 No. 1

Notice is hereby given pursuant to paragraph 2 (3) of the Sixth Schedule to the Highways Act 1980 that the Secretary of State proposes to modify the Borough of Dartford Public Path Diversion Order 1979 No. 1, by providing that the proposed diversion of footpath No. 77 should commence at the point marked A on the Order map, that is a point 40 metres south-west of the railway being the point marked M on the map, and run in a generally westerly direction for a distance of approximately 260 metres to the point marked I on the map and then in a southerly direction for a distance of approximately 220 metres to the point marked E on the map.

A copy of the Order and map as submitted, and a copy of the Schedule to the Order and a copy of the map showing the proposed modification, have been deposited and may be inspected free of charge at the Dartford Borough Council Offices, High Street, Dartford, between the hours of 9 a.m. to 5 p.m. Monday to Thursday and 9 a.m. to 4.30 p.m. Friday.

Any representation or objection with respect to the proposed modification may be sent in writing to the Secretary of State, Department of the Environment, Charles House, 375 Kensington High Street, London W14 8QH (quoting Ref. SE2/5274/151/2), not later than 30th April 1982, and should state the grounds on which it is made.

TOWN AND COUNTRY GENERAL REGULATIONS 1976

The Secretary of State for Transport hereby gives notice that he has made an Order entitled "The Conversion of Highways into Footpaths or Bridleways (District of Barnsley) (No. 1) Order 1982". The Order comes into operation on 26th March 1982 and extinguishes any right which persons may have to use vehicles (other than those specified in Schedule 2 to the Order) on 4 areas of unnamed highway off King Street and Queen Street, Thurnscoe.

Copies of the Order may be obtained, free of charge, by applying to the Director (Transport), Yorkshire and Humberside Region, Room 913, City House, New Station Street, Leeds LS1 4JD (quoting Ref. If any person aggrieved by the Order desires to question its validity, or the validity of any provision contained in it, on the ground that it is not within the powers conferred by the above Act or that any requirement of that Act or of any regulations made under it has not been complied with in relation to the Order, he or she may, within 6 weeks from 26th March 1982, apply to the High Court for the suspension or quashing of the Order or of any provision contained in it.

Unless the Order is suspended or quashed as a consequence of any such application, any person who on 26th March 1982, has an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Barnsley Metropolitan

Borough Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the Council at its above address within a period of 6 months from 26th March 1982 unless the period is extended in any particular case by the Secretary of State.
