Notice is hereby given that the Council of the Borough of Broxbourne in pursuance of their powers under section 277 of the Town and Country Planning Act 1971 (as amended by the above) have designated land at High Road, Broxbourne, as a Conservation Area and such land is described in the Schedule below.

With certain exceptions buildings in the Conservation Area may not be demolished without the written consent of the Borough Council. In addition trees (with certain exceptions) in the Conservation Area may not be lopped, topped, felled, uprooted or wilfully damaged or destroyed unless notice of the proposed action has been given to the Director of Technical Services, Council Offices, High Street, Hoddesdon, and permission to proceed has been received, in writing, from the said Council or it has failed to take any conclusive action regarding the notice within 6 weeks of the date of service.

Copies of the map showing the boundaries of the Conservation Area have been deposited at the Planning Offices of the Director of Technical Services, The Council of the Borough of Broxbourne, Council Offices, High Street, Hoddesdon, and also with the County Planning Officer, County Hall, Hertford, and may be inspected, without charge, during normal office hours from Monday to Friday inclusive.

#### SCHEDULE

The properties which, together with their curtilage, are included in the Conservation Area are:

All properties in The Lawns Drive.

No. 2 Cozens Lane East.

Nos. 2, 4, Yew Cottage, The Lodge, 8 and 10 Cozens Lane West.

The Bungalow Broxbourne School, Broxbourne School, 168 High Road, Broxbourne (western side).

Nos. 155, 157 Kingfisher, Spindlewood, Pleasington, 163-177 inclusive and 195 High Road, Broxbourne (eastern side).

The Conservation Area includes several areas of open space. Namely, open space adjacent to High Road, Broxbourne, fronting Hadleigh Court, the New River and footpath on its eastern bank and the junction of High Road, Broxbourne, with Bell Lane.

*The Hampshire (Bramshill Footpath No. 8 and Part of Bridleway No. 7) Public Path Diversion Order 1982*

Notice is hereby given that the above-named Order, hereinafter referred to as "the Order", made on 26th March 1982 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Hampshire County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to extinguish the lengths of paths specified in Part I of the Schedule hereto and to create an alternative highway as specified in Part II of the Schedule.

A copy of the Order and the map contained in it has been deposited at the office of the Clerk of the Council and Director of Administration, Hart District Council, Council Offices, Reading Road North, Fleet; at Mattingley Post

Office, Mattingley, and at the office of the undersigned and may be inspected free of charge during the usual office hours.

If you wish to be notified if the Order is confirmed and to have a copy of the Order as confirmed, you should write to the Hampshire County Council, The Castle, Winchester, giving your name and address to which the documents should be sent.

Any representation or objection with respect to the Order may be sent in writing to the Hampshire County Council not later than 23rd April 1982 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Hampshire County Council, may instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

#### SCHEDULE

##### Part I. Description of Sites of Existing Paths

Those parts of the rights of way in the Parish of Bramshill in the District of Hart shown on the Definitive Map of Public Rights of Way prepared under Part IV of the National Parks and Access to the Countryside Act 1949 as described below:

##### A. Footpath No. 8

The entire length of Bramshill Footpath No. 8 being an appropriate distance of 445 metres.

##### B. Bridleway No. 7

That part of Bramshill Bridleway No. 7 which commences at a point approximately 40 metres from its junction with Plough Lane and runs generally southeastwards for approximately 456 metres.

##### Part II. Description of Sites of Alternative Highways

##### A. Footpath No. 8

A 1.2 metre wide earth path which commences at the north-western end of the path described in Part I B of this Schedule and runs north-north-eastwards for approximately 134 metres then generally east-north-eastwards for approximately 392 metres then onto a 1.8 metre wide enclosed earth path running south-eastwards for approximately 170 metres then onto a 1.2 metre wide earth path and running southwards for approximately 163 metres, a total distance of approximately 859 metres.

##### B. Bridleway No. 7

A 1.8 metre wide earth path which commences at the north-western end of the path described in Part I B of this Schedule and runs south-south-westwards for approximately 48 metres then onto a 2.5 metre wide enclosed earth path and running generally south-eastwards for approximately 448 metres then onto a 1.8 metre wide earth path and running east-north-eastwards for approximately 48 metres then north-eastwards for approximately 104 metres then northwards for approximately 84 metres to reconnect with the existing path. A total distance of 732 metres.

##### Designation of Conservation Area

*River Wey Conservation Area, Parts of the Parishes of Bramshott and Liphook, Headley and Linchmere*

Notice is hereby given that by a resolution dated 9th February 1982 the East Hampshire District Council on its own behalf and under section 101 of the Local Government Act 1972 on behalf of the Chichester District Council, designated certain parts of the Parishes of Bramshott and Liphook, Headley and Linchmere, as a Conservation Area for the purposes of the Town and Country Planning Act 1971, section 277. Such Conservation Area to be known as the "River Wey Conservation Area". The area concerned is defined by reference to a map copies of which are
