NOTICE OF PUBLIC PATH ORDER

Leeds City Council (Morley Footpath No. 33 (Part) Deadhead Lane) Public Path Diversion Order 1982

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order" made on 26th March 1982 is about to be submitted to the Secretary of State for the Environment and Transport for confirmation or to be confirmed by the Leeds City Council as an unopposed Order.

The effect of the Order, if confirmed without modifications will be to divert the public right of way running from a point at the north-easterly end of the pedestrian subway 330 metres approximately south-east of the railway bridge, Elland Road and proceeding in a northerly direction for a distance of 219 metres approximately to a point where the footpath divides to the north-east and north-west. The north-easterly section of footpath continues for a distance of 219 metres approximately to its junction with Millshaw. The north-westerly section of footpath continues for a distance of 187 metres approximately to its junction with Millshaw and Elland Road. The alternative footpath route commences at the point previously described as being the beginning of the footpath to be diverted and proceeds in a north-westerly direction for a distance of 244 metres approximately and then in a north-easterly direction for a distance of 131 metres approximately. Thereafter the footpath continues in a north-westerly direction for a distance of 122 metres approximately to its junction with Millshaw and Elland Road.

If the Order is submitted to the Secretary of State for confirmation and representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
